F15/1351 2016-17 PRECEPT

Following suggestions by Councillors at the Full Council meeting on 9 December 2016, the Clerk went through the proposed budget for 2016-17 explaining that all budget heading had been scrutinized to ensure best value. The Parish Council have committed to allocated a new budget for Community Events and a new budget for Youth Provision. The Clerk then went through the following proposals for Precept increases:

- 0.9% increase would allow £3k budget for Community Events and £3k budget for Youth Provision with an increase of £0.81 per year for Council Tax Band D.

- 1.8% increase would allow £4k budget for Community Events and £4k budget for Youth Provision with an increase of £1.66 per year for Council Tax Band D.

- 2.7% increase would allow £5k budget for Community Events and £5k budget for Youth Provision with an increase of £2.51 per year for Council Tax Band D.

Cllr Saini suggested that the Precept should be increase by 3% to ensure that all costs associated to the running of the Parish Council are covered, with a small amount left over in case of emergency. A 3% increase would increase Band D Council Tax calculation by £2.82 per annual, 0.24p per month.

ACTION: Cllr Saini proposed that the Finance Committee should recommend to the Full Parish Council an increase to the 2016-17 Precept of 3%, which was seconded by Cllr Evans and unanimously agreed by the Finance Council.
