17/6730 CLERK'S REPORT

The Clerk presented the following report

Community Centre

- 1. Room Bookings –. Following funding cuts by the Borough council, Shropshire Wildlife Trust Green Heroes project will now end and they will vacate building from June. We are currently seeking new tenants and/or letting out as a meeting room to local organisations and businesses.
- 2. Leegomery Computers have been in contact regarding IT support and providing agendas and reports electronically by training councillors to use handheld tablet devices. They have successfully implemented at Wellington Town council. They have provided quotation for IT support which is 50% cheaper than current service. Currently seeking other quotations and will arrange a further presentation on this matter
- 3. Arty Party have confirmed a further weekly room booking which started in June and are also renting storage space for equipment at £50 per month
- 4. Assistant to Clerk currently working on improvements to invoicing/receipting procedures and also negotiating with hirers on a number of new regular weekday bookings and one off weekend bookings for the Centre
- 5. Hanging baskets and tubs on show at front of building Facilities Management Officer has put these together

Parish Environmental Team

6. Telford & Wrekin have acknowledged the question of what the Parish will be given in terms of finance or works for the cost of the unfilled PET apprentice post and have agreed there is £11.6k that can be spent on public realm works. Councillors to approve suitable projects for expenditure

- 15. Former Centre Manager and Centre Cleaner have taken voluntary redundancy and finished at Centre 19 May and 5 May respectively with redundancy payments scheduled to be paid at end of June.

Councillor Millward-Thomas updated councillors on youth work being undertaken. The Fitness & Fun Camp sessions which had taken place at Meadows Primary school had been successful. Presentations were taking place on 16 June at the school with Veolia attending.
